CRITERIA TO BE USED IN ESTABLISHING THE ELIGIBILITY LIST:

- Review of application and supporting documents
- Written exam
- Practical exam
- Physical agility test
- Panel oral interview
- Chief's interview

NOTE: Dates and time for the above will be emailed to individuals that submit completed applications by the closing date.

NOTE: Preference points will be awarded for military service if a valid DD form 214 is submitted with the candidate's application.

The firefighter works under the supervision of a fire captain or his/her assigned representative. The firefighter responds to alarms and protects life and property by performing firefighting, emergency medicine, hazard control and other duties as assigned. The firefighter also maintains fire and emergency medical equipment, apparatus, and facilities. **(SEE POSTED JOB DESCRIPTIONS)**

MINIMUM QUALIFICATIONS:

- 18 years of age or older at time of hire
- A valid Arizona driver's license
- High school diploma or G.E.D. equivalent
- Arizona Firefighter I and II certification or NFPA 1001 equivalent
- Arizona Certified EMT-Basic or Paramedic
 - Advanced Cardiac Life Support for paramedic applicants
 - Pediatric Advanced Life Support for paramedic applicants
- Healthcare Provider level CPR certification
- Hazardous Materials First Responder; Operations Level
- Basic Wildland certification (S-130, S-190, and L-180)
- Ability to speak, read, and write the English language
- Meet physical standards and the insurability requirements of the District's insurance carrier

FULL-TIME BENEFITS (wages and benefits are approved by the Board of Directors and subject to change)

- Public Safety Personnel Retirement System retirement plans. Tier2 and Tier3 employees receive employer matching contributions to deferred compensation savings plans
- Medical and dental insurance programs, optional vision insurance and AFLAC available
- Life insurance, cancer insurance, long term and short-term disability insurance programs
- Employee assistance program, paid vacation and sick leave, uniform allowance
